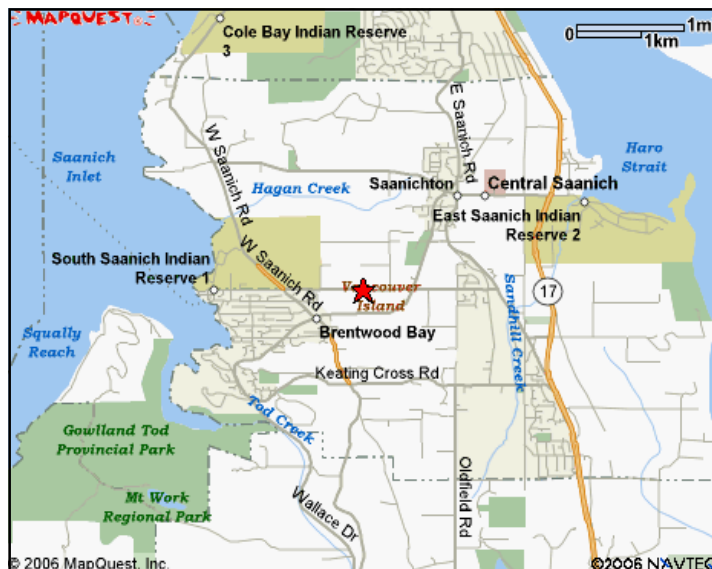

LOCATION: Saanichton Fairgrounds FROM VICTORIA FERRY TERMINAL

- Take hwy #17 to Mt Newton X Cross. (Whitespot, Super 8)
- Turn RIGHT at these lights and go 1.25 km to the 4 way stop. Straight through this intersection and LEFT on Wallace drive.
- Go 1.25 km down Wallace drive and turn RIGHT at the four way stop. This is Stelly's X Road.
- Go 1km along this road you will see the Saanich Fairgrounds sign on right just across from Stelly's school.

FROM UP ISLAND

- Enter Victoria via hwy#1.
- Keep to the left lane and turn left onto McKenzie (sign reads Airport/Ferries)
- Go 2 km to #17 north (stay in right hand lane sign read north to Sidney and BC Ferries.
- Go 15km to Mt Newton X Road Turn left at lights (white spot, Super 8)
- Go 1.25 km to the 4 way stop. Straight through this intersection and LEFT on Wallace drive.
- Go 1.25 km down Wallace drive and turn RIGHT at the four way stop. This is Stelly's X Road.

NOTICE TO EXHIBITORS

Exhibitors through submission of entry, acknowledge that they are knowledgeable of the AAC rules and regulations, including but not limited to the following

- This event is open to all dogs being at least 18 months of age, purebred or mixed, except bitches in season, aggressive dogs, or dogs suffering from and deformity, injury or illness which may affect the dogs physical or mental performance or which may effect any dog entered at the this trial.
- No leads, collars, food or toy or any other aids shall be permitted on the course at any time including familiarization. The lead and collar may be used to enter and exit the ring but must be removed prior to running on course.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and children. Any exhibitor whose dogs or children create unnecessary disturbance or engage in unsafe or disruptive behavior will be asked to leave the show grounds and **NO REFUND WILL BE GIVEN.**
- Dogs who show aggression at any time on the show grounds and or are uncontrolled by the exhibitor will be asked to leave immediately. **NO REFUND WILL BE GIVEN.**
- Exhibitors must keep crate area clean and must pickup after their dogs.
- You must have a valid AAC Number and present your card at check-in for each dog entered at the trial.
- **YOU ARE RESPONSIBLE FOR YOUR DOG, YOURSELF AND THOSE WITH YOU AT ALL TIMES.**
- Upon receipt of entry, there will be **NO REFUNDS OR CREDITS.** No exceptions, **unless vet certificate provided!**

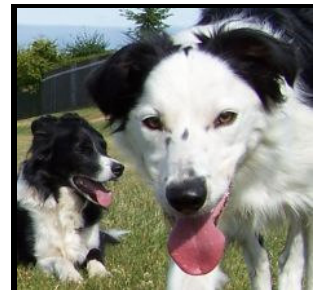
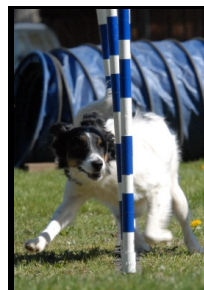
